

Confirmed. & by these Presents Doth Grant, bargain, sell, alien, Release
 & Convey unto the v^d Peter Hasten (In his Actual possession now being
 by Virtue of a Bargain & sales to him thereof made by the said Henry
 Haster sen^r for one whole Year by Indenture bearing Date the Day
 Next before the Day of the Date of these Presents, and by force of the
 Statute for transferring Titles into Possession) and his heirs A certain
 Piece or Parcell of Land, lying & being in the County of Dummore on the South
